

FYC Viewing Platform Spec Sheet

ASSET GUIDELINES

- **DO NOT** include “FYC” on the logo or key art.
- **DO NOT** include laurels of any kind.
- **DO NOT** include blatant campaigning language (i.e. VOTE, CHOOSE, anything along the lines of VOTE FOR ME etc.).
- **DO NOT** include show tune-in (i.e. “Mondays 8PM” or “Streaming Now”).
- **DO NOT** include specific Emmy® categories on the key art.
- **DO NOT** include additional text such as cast or producer names, editorial/press quotes, show description, website links, or other awards/accolades.
- **DO NOT** include the gold “For Your Consideration” banner in your email image design as it is part of the email template.
- **DO** include network or studio logo on the 650px width email image, in addition to whichever programming you are promoting.

NOTE:

The above pertains to the viewing platform only, not the invitation and event copy.

LOGOS

Program logo



The program logo or key art is a square image (600px x 600px minimum) and must include the program title.

JPG or PNG, not on a transparent background.

Maximum file size is 400kb.

Broadcast/cable network, studio or platform logo



The broadcast/cable network, studio or platform logo is a square image (600px x 600px minimum).

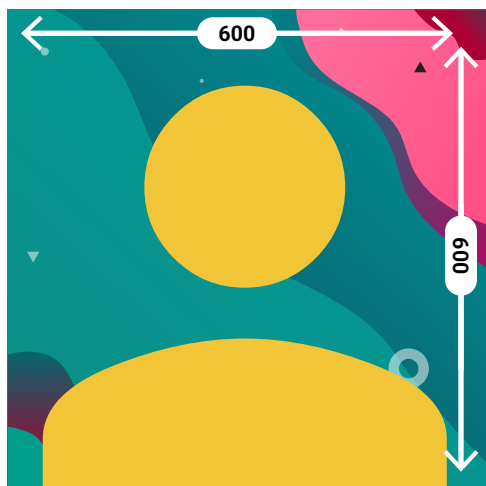
JPG or PNG, not on a transparent background.

Maximum file size is 400kb.

HEADSHOT

Headshot (for performer categories)



The headshot image is a square image (600px x 600px minimum). Color photo preferred.

JPG or PNG, not on a transparent background.

Maximum file size is 400kb.

EMAIL IMAGE

Email image (for program categories only)



The email image (650px x max. 800px) is used for the viewing platform email. The height is variable, however 800px is generally a good benchmark.

JPG, PNG, or GIF at 72dpi resolution.

VIEWING PLATFORM CODES

Viewing Platform Codes (not required if using TVA viewing platform)

A generic/easy to remember viewing code is recommended. For example, [your network/studio's abbreviation] FYC2025 [XXXFYC2025].

Viewing Platform codes must NOT contain any spaces or any of the following special characters: & # ; : < > - " ' = _

If your site requires unique access codes, at least 30,000 codes will be required and provided by you in a spreadsheet - CSV or XLSX. Additional codes may be needed if the membership count is exceeded.

Codes must expire by September 30, 2025.
