

TELEVISION ACADEMY TICKET TERMS AND CONDITIONS

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY AS THEY GOVERN YOUR RIGHTS UNDER THE TICKET AND CONTAIN A BINDING, INDIVIDUAL ARBITRATION AND CLASS-ACTION WAIVER PROVISION BY WHICH YOU GIVE UP THE RIGHT TO FILE A LAWSUIT IN COURT INDIVIDUALLY OR AS PART OF A CLASS ACTION WITH RESPECT TO ANY DISPUTES RELATING TO THE TICKET OR THE SPECIFIED EVENT FOR WHICH IT IS ISSUED.

This ticket ("Ticket") provides the individual in possession of it ("Holder") a personal, revocable license for admission to the venue identified on the front of the Ticket ("Venue") for the sole purposes of attending and viewing the event identified on the front of the Ticket ("Event"), only for the duration of Event and only for Holder's personal entertainment purposes, subject to the additional terms and conditions set forth herein. Use of this Ticket for admission to Venue and/or Event constitutes acceptance by Holder of all of the terms and conditions set forth herein. If Holder is a minor or legally incapacitated adult, he or she must be accompanied by a parent or guardian with a Ticket, and the parent or guardian must and hereby does bind the minor or legally incapacitate adult to these terms and conditions. IN THE EVENT HOLDER DOES NOT WISH TO OR IS NOT ABLE TO AGREE TO THESE TERMS AND CONDITIONS, HOLDER SHALL NOT ENTER OR ATTEMPT TO ENTER VENUE OR EVENT.

By using this Ticket to gain admission to Venue or Event, Holder irrevocably authorizes and consents to being filmed, photographed, interviewed, and/or otherwise recorded while at Venue and Event (such films, photos, interviews, and recordings, collectively "Recordings"). In connection therewith, Holder grants to Academy of Television Arts & Sciences ("Television Academy") on an irrevocable, perpetual, and nonexclusive basis the right to use any Recordings and to have Holder's name, image, voice, and/or likeness (and any related performance) broadcast, displayed, copied, licensed, publicized, and/or used in any other manner and on or in any other media or medium (e.g. video, streaming, radio, television, Internet, social media) now known or hereafter developed, without any requirement of additional consent or consideration. Holder hereby assigns to Television Academy any and all right, title, and interest Holder may have in and to all such Recordings, and Holder hereby waives any and all right of approval or inspection with respect to the Recordings and the use thereof. These rights are licensable and assignable in whole and in part by Television Academy.

Holder assumes all risk of personal injury and personal property loss or damage in connection with Holder's presence at Venue and/or Event, including any travel to, from, or between the same. Holder hereby releases, discharges, and holds harmless Television Academy, Venue, "Released Parties" (defined below), all of their respective sponsors, and any broadcaster, cable provider, webcaster, media outlets, and exhibitor of Venue and/or Event (and any and all of the foregoing entities' parents, subsidiaries, and affiliates and each of their respective officers, directors, members, employees, contractors, shareholders, and agents) from and against any and all liability for injury, loss, or damage to person or property incurred in connection with or arising out of Holder's attendance at Venue and/or Event. Holder expressly waives all rights, benefits, and protections it may have under California Civil Code § 1542, which reads: A

GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE AND THAT, IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY. Venue and Event are provided ASIS, AS-AVAILABLE and, to the maximum extent permitted by law, without warranty of any kind, express or implied, as to any matter whatsoever, including without limitation the condition of Venue and Event. In no event will Television Academy, Venue, or Released Parties (or any of the other releasees identified above) be liable for any indirect, consequential, exemplary, incidental, special, or punitive damages or for lost profits, revenues, or business opportunities even if advised of the possibility of such damages and even if any other remedy fails of its essential purpose. To the maximum extent permitted by law, the maximum monetary liability of Television Academy, Venue, and Released Parties (and any of the other releasees identified above) arising in connection with the use of this Ticket and/or attendance at Venue and Event shall not exceed the sum of US\$10.00.

Holder will be subject to and consents to all security searches, screenings, and inspections of Holder's person, bags, clothing, and other articles for security purposes, whether by walk-through metal detection, handheld metal detection, bag checks, physical pat-downs, or otherwise. Holder acknowledges and agrees to comply with all applicable policies and protocols implemented by Television Academy, Venue, and Event, including without limitation any policies and protocols regarding security, attendee conduct, and health and safety, all of which, due to their evolving nature, may continue to be updated from time-to-time between the time of receipt of this Ticket and the date of the Event.

Use of cameras or devices of any kind for the purpose of recording Event is strictly prohibited. Television Academy, Venue, and Event each reserve the right to deny or revoke Holder's access or admission to Venue and/or Event for any reason in their sole discretion. ANY SUCH DENIAL OR REVOCATION OF ACCESS OR ADMISSION WILL IN NO WAY ALTER, REVOKE, OR OTHERWISE LIMIT (i) THE RIGHTS AND LICENSES GRANTED BY HOLDER WITH RESPECT TO RECORDINGS, OR (ii) HOLDER'S ASSUMPTION OF LIABILITY AND INDEMNIFICATION OBLIGATIONS AS PROVIDED HEREIN. This Ticket and the obligations of Holder described herein are non-transferable and non-assignable by Holder. The terms and conditions of this Ticket shall be governed and construed in accordance with California law, without giving effect to conflict of laws principles thereof. To the maximum extent permitted by law, the state and federal courts sitting in Los Angeles, California shall have exclusive jurisdiction over any dispute arising between you and Television Academy, Venue, and Released Parties (and any of the other releasees identified above) that are not subject to arbitration (as set forth below). Unless otherwise agreed in writing by Television Academy, this Ticket shall not be resold or used for promotional, licensing, charitable, or similar purposes. This Ticket has no cash value, and there is no right to refund or credit if Event is rescheduled and/or cancelled. Payment (if any) for the Ticket is not tax deductible as a charitable contribution. If any provision of these terms and conditions is held by a court of competent

jurisdiction to be unlawful, void, invalid, or unenforceable, the remaining provisions shall remain in full force and effect.

PLEASE READ THIS SECTION CAREFULLY. IT MAY SIGNIFICANTLY AFFECT YOUR LEGAL RIGHTS, INCLUDING YOUR RIGHT TO FILE A LAWSUIT IN COURT. YOU HAVE THE LIMITED RIGHT TO OPT OUT OF THE ARBITRATION AGREEMENT IN THIS PARAGRAPH AS SET FORTH BELOW. Should any current or future dispute, claim, or cause of action related to this Ticket or Event arise between Holder and Television Academy, Venue, or any of Released Parties (and any of the other releasees identified above), a written notice ("Dispute Notice") must be sent with the following information: (i) name and contact information (address, telephone number, and email address); (ii) a description of the nature and basis of the dispute; and (iii) a description of the nature and basis of the relief sought, including a calculation for it. If the Holder has a dispute, he or she shall send the Dispute Notice to Television Academy, 5220 Lankershim Boulevard, North Hollywood, CA 91601, Attn: Legal Notices. Holder and Television Academy, Venue, or Released Parties (as applicable) agree to make a good-faith effort to resolve the dispute for at least 60 days ("Negotiation Period") following receipt of the Dispute Notice. If the parties cannot resolve the dispute within the Negotiation Period, the dispute shall be resolved by binding arbitration. The arbitration shall be administered by American Arbitration Association ("AAA") and heard by a single, neutral arbitrator, in English, in Los Angeles, California. The AAA Rules shall govern the payment of all arbitration fees. Notwithstanding the foregoing, Television Academy, Venue, or Released Parties (as applicable) will consider a request to reimburse your portion of the arbitration fees upon a showing of hardship in its/their sole discretion and assuming you do not qualify for a waiver from AAA. All issues are for the arbitrator to decide except the following items (which are for a court of competent jurisdiction to decide): (a) issues that are specifically reserved for a court; (b) issues related to the scope and enforceability of the arbitration provisions; and (c) whether a dispute can or must be brought in arbitration. In addition, Holder may be entitled to seek public injunctive relief in arbitration. TO THE MAXIMUM EXTENT PERMITTED BY LAW, HOLDER, TELEVISION ACADMEY, VENUE, AND RELEASED PARTIES AGREE THAT ALL DISPUTES SHALL BE ARBITRATED ON AN INDIVIDUAL BASIS AND WAIVE ANY RIGHT TO LITIGATE IN COURT OR ARBITRATE ANY CLAIM AS A CLASS ACTION, REPRESENTATIVE ACTION, OR CLASS ARBITRATION. TO THE MAXIMUM EXTENT PERMITTED BY LAW, HOLDER, TELEVISION ACADMEY, VENUE, AND RELEASED PARTIES WAIVE THE RIGHT TO A JURY TRIAL. You have the right to opt out of arbitration by sending the Television Academy a personally signed, written notice of your decision to opt out to the notice address above within the earlier of the Event date or thirty (30) days after receipt of this Ticket. Such an opt-out will not opt you out of an arbitration agreement you might otherwise have with the Television Academy, Venue, and/or Released Parties.
